

Midmark Foundation Scholarship

1. Midmark Foundation has established scholarships, to be called “The Midmark Foundation Scholarship”.
2. The Scholarships shall consist of (2) scholarships for \$5,000 per academic year and the recipient must be classified as a full-time student. Upon award of a scholarship and the recipient’s acceptance at an accredited school, arrangements will be made between the foundation and the school as to method of payment on a school term basis, provided, however, that all scholarship payments shall be made directly to the school. As part of the arrangement between the school and the foundation, the school shall agree to use the scholarship to defray the recipient’s tuition only, as long as the recipient meets the criteria set forth in Paragraph 4.
3. The scholarships will be awarded for each academic year if enough applicants have been received to justify a second scholarship. (IRS regulations require four applicants for each scholarship awarded.) Otherwise, just one or two \$5,000 scholarships will be awarded. If the recipient meets the qualifications the scholarship will be renewed for his or her subsequent years. It is the intention that this scholarship be used for the pursuit of either a four-year bachelor’s degree or a two-year associate degree at an accredited college, university, and business, technical or specialized school.
4. At the end of each academic year, the recipient will be awarded a renewal of the scholarship for the subsequent year provided he or she has carried at least 12 credit hours each quarter, or semester, has achieved an accumulative grade point average of 3.0 (B or better), and has not been subjected to disciplinary action for misconduct. The recipient agrees to permit the school to furnish the foundation with a transcript or copy of his or her grades and such other data as the school shall deem useful or advisable in helping the foundation administer the scholarship program. If the recipient has a grade point average of less than 3.0 at the end of his or her academic year, the scholarship may be renewed at the discretion of the scholarship committee. During each academic year, the recipient will be expected to maintain grades high enough to avoid academic probation, and to otherwise meet the standards required to keep in good standing.

5. These scholarships shall be awarded without regard to race, color, sex, religious affiliation, national origin, or age. To be eligible to apply, a student must meet the following qualifications:
 - a. Be a natural born child, legally adopted, or stepchild of a full-time/part-time teammate of Midmark Corporation. Children of officers/board members of the foundation are not eligible.
 - b. Be a high school graduate in the upper 50% of the graduating class at the time the scholarship is awarded and must have taken a college preparatory course.
 - c. Must submit scores from either the A.C.T or S.A.T. tests.
 - d. Must furnish at least three letters or reference, one of which must be from the high school principal, neither of the other two references may be from relatives.
 - e. Must write an essay of 250 to 500 words explaining his or her goals, ambitions, family background, field of interest, and reasons for desiring a college education.
6. The basis of selecting the recipient will be academic scholarship, citizenship and leadership.
7. The scholarship committee is independent of management foundation. This committee has the complete authority of selecting and no member of Midmark Foundation shall be a member of the committee. The winning recipients will receive his or her award from a representative of Midmark Foundation.
8. The complete application should consist of:
 - a. Application completed and signed by applicant and his or her parents.
 - b. Applicant's essay of 250 to 500 words. Letter from principal with complete transcript and A.C.T. or S.A.T. test scores.
 - c. Letters from two other persons.
9. **All applications must be received by Friday March 29, 2024 of their senior year to receive consideration.** Use the attached blank application. Send completed applications to:
