BOARD BRIEFS

The following is a summary of the Regular Board of Education Meeting held on September 12, 2022.

- The Board approved minutes of the Regular Business Meeting held on August 15, 2022. The monthly financial report indicated August General Fund receipts of \$881,956 and expenditures of \$1,023,853. The anticipated carry-over balance for the end of the 2021-2022 fiscal year is \$7,009,469.
- In the Elementary Principal's report, Scott Rodeheffer reported as follows:
 - 1. We have 11 students helping with Safety Patrol this year and over 40 students helping with Flag Patrol. We are the only school in Shelby County that still has a Safety Patrol team.
 - 2. Our third graders have been invited out to the Fall Fest at Lake Loramie to visit the Mountain Men Encampment on Friday. They will be able to explore the different tents and talk to some of the participants.
 - 3. We will be having a Food Drive for SVDP the week of October 10th.
